

To Whom This May Concern;

I am writing this letter in regards of how I am being treated in this County Jail. I was told about FFUP only once so my apologies if I misunderstood what this program is about. To give you a short introduction I'm a 23yr old Native American from a reservation located here in Hayward WI. "Lac Courte Oreilles" short "LCO" I been struggling with the system since the age of twelve years old. Been in and out of incarcerations. Been to adult prison twice served my first term at GBCI was released 2017 and went back to serve reversion at Dodge. Released March of this year. I caught most of my crimes under the influence and at a real young age of 16 and 17 now I got to show on them for years. Being in a small town is bad news when you have a bad history. I was wild and wanted the spotlight as you can say. But I've grown up now and learned my lesson about certain things. My past still follows me though like a shadow. Every single cop knows me because of my County Jail history or rumors. I'm always being judged or accused never believed.

For instance what I came in I needed to go on suicide watch I told them I

Wasnt feeling right. As I was coming off of heavy
Drugs. They Refused to put me on Suicide watch
AND left me Alone. SO I Covered up My Cell
Block windows To get the jailers Attention
Next they Came in with ROAD COPS AND I
AGAIN SAID I need to go on Suicide watch. BUT
They open the door TAKE ME A TOTAL OF ONE WITH
THE PRINGS AND 3 TIMES HAND HELD. SO they
CUFFED ME AND put Me in A Cell with just
A Concrete slab AND A hole in the ground AS the
TOILET. NO Bed. NO Suicide SHMOCK Nothing just
The clothes on my Back AND left me in there.
NEXT what they Do go HANDS off they have
TO DO A Medical PROTOCOL which WASNT Done
until the next Day when I kept Complaining
OF INJURIES AND that I WAS still going to harm
MYSELF By Hitting my Head. which I did. TO which
the DRUGS / JAILERS DID NOTHING. the JAIL LT. WAS
APART OF THIS AND I asked to File a
Complaint AND He said They acted Accordingly
Due to my Behavior. I Copied this AND I wish
to file a suit. I AM just Clueless ON how to
go about it. I AM constantly Being Treated here
I CANT even Recieve proper mental or Physical
Health Treatment. I am Diagnosed with Bipolar
Depression, Anxiety, Seizures and Chronic migraines
ADHD. AND They wont give me no
medication Because I used to Drugs out

Side of jail. I substituted my meds with Street
Drugs. Not that I abused them just that I never
chose to pick them up because I was using
other drugs. Now they said I don't get any meds.
It's hard for me to cope. I'm locked down
23 hrs a day for that incident trying to
harm myself plus I'm not medicated. I don't
know what this program is about but if
there is a chance you can help me
please do.
